### About this Newsletter

### Background

The Department of Water Resources (DWR) is undertaking this project to rehabilitate storm drain pipe at four locations throughout the County:

- Green Eyes Way, Green Top Way & Greenback Lane
- Lantern Court & Fair Oaks Boulevard
- Oakhollow Drive, Roseville Road, Tarleton Drive & Crowder Way
- Winsford Lane & El Camino Avenue

### Project Description

The project will rehabilitate the pipe with Cured-In-Place Pipe (CIPP) lining. CIPP lining installs an inner lining within the existing pipe creating a new pipe without the complications of traditional remove and replace construction. The project will line 15 pipe sections totaling 1,550 lineal feet to mitigate corrosion, root intrusion, and risk of pipe failure.

During the lining installation, there will be a noticeable odor, often described as plastic or glue-like. The odor is temporary and typically dissipates within hours of installation.

### Project Updates

The project design was finalized in May 2025 and the Sacramento County Board of Supervisors approved putting the project out to bid on May 13, 2025. The project received three bids on June 12, 2025. The

project was awarded to the lowest bidder Lamassu Utility Services Inc. on June 26, 2025.

### Quality Control

Sacramento County Construction Management and Inspection Division (CMID) will manage all field work and inspections for the project. Mariano Tabbada is the construction inspection supervisor. He will resolve most field issues and ensure the work meets the design plans and specifications. Gabe Apgar is the Resident Engineer. He will oversee construction and handle major field issues.

### Project Schedule

- Board of Supervisors Approval – May 2025
- Bid Opening – June 2025
- Construction: August 2025 – November 2025
