Phase 2A: Arden Service Area Pipe and Meter Installation Project

Project Updates

As of late-August, Teichert has completed installation of over 17,000 feet of pipe with the Phase 2A Arden Service Area Pipe and Meter Installation Project (Phase 2A Project). Additionally, all of the water service piping has been installed up to the meter boxes. Water mains remain empty until proper testing, disinfecting and flushing are performed, which is tentatively scheduled for the first week of September. Expect night work on Watt Ave., and day work on American River Dr. and nearby cul-de-sacs. Similarly, new service connections from the meter boxes back to the homes are not connected until we have confirmed the water main has been successfully tested. During the flushing of the new water mains, you will be seeing water discharged into storm drain inlets and sewer manholes throughout the project area. Please do not be alarmed by the volume of water needed to flush the new mains. Additionally, residents in and near this area may be affected by noise and lights during the course of the night work.
